








































Serving the Public... Together!

INDING THOSE in need of our services can be a challenge when we first decide to offer our help. It is easy to take a look at the Public Service landscape and see a lot of agencies already well-established. How can we offer to help these helpers without looking presumptuous? Or worse yet, being told to "go away?"

The answer is actually pretty simple. In a word, "volunteer." Putting that simple tactic into action, though, is a bit more involved than paying mere lip-service.

The first thing we have to do is to take stock of our abilities and know what we are capable of and what our limitations are. It is better to "underpromise and overdeliver" than the other way around!

Second, we need to promise ourselves to live up to our responsibilities to deliver what we promised. Here is where a lot of groups drop the ball. If, for example, we offer to provide communications along a parade route, nothing hurts our credibility more than failing to show up with enough people to do the job.

Finally, after the event is done, we need to take time to review our performance, and even to invite critiques of our efforts. If we are mature and realistic, we will realize there is *always* room for improvement. Here is where a little tact and humility can be useful.

Nobody likes to be told they could have done better, but the fact is we can. By being open to the possibility that we don't know everything, and by becoming willing to learn, we'll be ready to work and play well with others.

Who are those "others?"

If you take a look at our front page, you will see a few of them. The astute reader will observe that our clubs are included with the served agencies. We can serve each other, and we need to take a broader view of the value we offer to one another.

The front cover also shows that we are in good company. No one can dispute the valuable services offered by each and every one of those agencies. And this is just the tip of the iceberg. The list in many communities could easily be doubled—or even tripled!

Making Contact

Once we have decided what we can offer and who we can offer it to, it's time to become more involved. We need to put our best foot forward, and be as professional as we can when making our first impression. A club should send its best spokesperson.

A well-written letter to the appropriate staff person in an agency will go a long way to opening the doors. By doing some research about an agency, we can see what their needs may be, and we will be better received if we are "answering a call."

The worst mistake we can make is to show up uninvited in the middle of their operation and proclaim, "We're here to help. Now get out of our way."

Laying the Groundwork

Lao Tzu wrote, "The journey of one thousand miles begins with but a single step."

In today's world where perception becomes reality, it is helpful to our cause to be perceived as "helpful." If our clubs and our individuals are recognized as helpful members of our communities, we will be better received when we offer our ham radio services.

It really helps our cause when our members individually volunteer to serve their communities in some small way—even if many if not most of these community service opportunities have little to do with amateur radio.

For example you could volunteer to help clean up a community eyesore. Volunteer to work at a community bake sale. Ring a bell. Answer the phones for a charity. Visit the homebound and the infirm. Deliver Meals on Wheels TM .

When individual hams do any of these things, they make themselves known as "good people" in their communities. When a ham radio group consists of known good people, a lot of doors are opened when we come knocking.

Everybody Wins

We amateur radio enthusiasts have a lot to offer our communities in times of need. We, like all people, enjoy receiving recognition for a job well done.

Likewise, every community has needs that they can't pay for with anything other than offering their thanks.

When you put these together with all the agencies that can serve and be served, there are opportuinities and benefits for all. It is by serving the needs of others that we show our better selves and our true value to our families, friends and communities.

I think this is the best meaning of "Serving the Public Interest, Convenience and Necessity."

Bryan WA3UFN announced an upcoming Skywarn training session is being planned.


The members were reminded that 2012 dues are now due, and that the 2012 Sustaining Membership campaign is now open for dimea-day and other donations to support the club's activities and projects.


43 Repeater News

The Big .43 Repeater is back on the air! Finally!

The tower crew from ComPros was at the repeater site and installed the new antenna. Also at the site was our own Filip AB3HK assisting and overseeing the installation process. All seems to have gone according to plan and the repeater is up and running.

The new antenna is a 4-bay Telewave model ANT150D6-9. This 4-dipole array design allowed us to create a custom directional signal in an attempt to fill in some of the nulls in our coverage area. Initial coverage reports are encouraging. Earlier Mike WB3EQW was able to work the repeater from the West side of Clearfield while mobile with a nearly full quieting signal. In the past the repeater did not reach into the Clearfield valley at all. If this is any indication, I'd say the new antenna is doing its job!





New 5MHz Rules March 5

ARRL BULLETIN



On November 18, the FCC released a Report and Order (R&O), defining new rules for the 60 meter (5 MHz) band. These rules are in response to a Petition for Rulemaking (PRM) filed by the ARRL more than five years ago and a June 2010 Notice of Proposed Rulemaking (NPRM). In the February 3 edition of the Federal Register, the FCC announced that these new rules will go

into effect on March 5, 2012.

In summarizing the new rules, the FCC explained that the new rules amend the current rules to facilitate more efficient and effective use by the Amateur Radio Service of five channels in the 5330.5-5406.4 kHz band (the 60 meter band).

The Amateur Radio Service in the United States has a secondaryallocation on 60 meters. Only those amateurs who hold General, Advanced or Amateur Extra class licenses may operate on this band.

Amateur stations must not cause harmful interference to – and must accept interference from – stations authorized by any administration in the fixed service, as well as mobile (except aeronautical mobile) stations authorized by the administrations of other countries.

Profiling Your Antenna

HE MOST important paper in your shack next to your FCC Ham license, is an antenna profile sheet. When I started in Ham Radio my Elmer taught me the importance of recording your antenna profile.

What is an antenna profile? Why is it important? Simply put, an antenna profile is a graphical representation of the SWR vs Bandwidth. If your use a resonant dipole, as half wave antenna, your SWR changes as you increase or decrease the frequency from the center frequency of the dipole.

The Basics:

A half wave dipole is one that is one half the length of the fundamental frequency in feet or meters. The formula for the length of wire necessary for a half wave dipole in feet, is 468/ freq(MHZ) = total length of a half wave dipole in feet. Therefore a Forty meter antenna is about 65 feet long at 7.2 MHZ. The dipole at the feed point is about 70 ohms not 50 ohms. When you feed a half wave dipole with 50 ohm coax you start off with an imbalance. If you cut your dipole at 67 feet long and check the SWR at 7150 Khz it may be close to 1:1.

The profile of the antenna is SWR plotted against frequency. Take a piece of graph

paper and on the X axis (horizontal line) write the frequency every 25 khz. Start with 7000 Khz up to 7300 Khz.

On the Y axis (Vertical) write the SWR starting with 1:1 up to about 5:1.

Take SWR measurements every 50 Khz and record them as dots where the X and Y axis meet. Example, if at 7000 Khz the SWR is 2.5:1 go up the Y axis to 2.5:1 and over to the X axis to 7000 Khz and record your first point.

When you finish you may have a U shaped curve when the dots are connected. Save this paper. If your antenna wire stretches, the curve will move down in frequency as the antenna becomes longer. If you think that you have an antenna problem you can always refer back to your initial antenna profile graph.

SWR Plot With Antenna Tuner

If you must use an Antenna Tuner you can plot an SWR curve and record the Tuner settings. This record will allow you to always check your settings against the initial recording. The second graph will explain how to record the settings from your tuner. Using graph paper , plot your SWR vs Frequency on the paper. Somewhere on the SWR side of the graph write the controls for your tuner as shown.

When your have your lowest SWR draw a line from the dot where the SWR meets the Frequency and fill in the numbers on the controls as shown. Once you have this record you can use it to quickly change bands and match the output of the transmitter to the antenna tuner. You can save this form in a clear plastic folder or a 3 ring binder.

This is a helpful tool that will show when you

your antenna or feed line. I have an MFJ 259B antenna analyzer that is an invaluable tool when erecting an antenna. This analyzer has many functions. I use it for a oscillator, Frequency standard, SWR bridge with resistance readout and a coax cable tester.

As simple as it sounds, this graph of your antenna may be the quickest way to evaluate your antenna when there is a problem.


